# **PROVINCIAL REPORTS**

# **ALBERTA**Peter Hansen

Greetings from Alberta. I hope all of you had a Safe and Joyful Holiday Season. The 2002 season seems like it has just ended and it is time to prepare for next year. Most of Alberta had at least a little snow over the Christmas season but it is far below normal and it's leaving everyone a little nervous about what to expect for the rest of the winter season.

Board of Directors meetings for the 4A's and Wild Rose Protective Fund were held the first part of January. Both meetings had good active participation by the members and some positive progress was made on the issues that were brought to the table.

For the 2003 season the Wild Rose Drift Fund is now planning to offer a \$50,000 Drift Coverage which will be optional for anyone wishing to increase their coverage from the \$25,000 mandatory coverage level. Also new for 2003 will be the inclusion of helicopters in the drift fund. The numbers are expected to be small but it will be offered to any operators who qualify. Also the fund will have an improved claim reporting system that should be in place by spring to assist any operators needing to make a claim during the season.

The 4A's meeting was held in Wetaskiwin with a full schedule of business items on the agenda. One of the main issues is the Regulations for the Transportation of Dangerous Goods, more specifically the transportation of avgas and jet fuel from one location to another. Most of us, as many of you probably know, are now illegally transporting our

aviation fuels down the highway. As a board we are researching different options to re-certify our existing tanks or the availability of new tanks that will be legal under the new regulations. More information on this as it becomes available.

Another topic of discussion was the broad interpretation of off target drift and the meaning of "adverse effect". There was much discussion on this and we are contacting Alberta Environment about our concerns on this issue.

It seems there are more issues and regulations evolving everyday and that is why we need active associations to stay informed and represent our industry on these issues. The Board members donate many hours of their time on these issues and to keep a strong association we need the continued support of the membership.

The CAAA Convention in Winnipeg is just around the corner; hope to see you there.

# SASKATCHEWAN Ted Anderson

The SAAA has submitted an "Expression of Interest" for the Delivery of Certain Elements of Saskatchewan's Forest Fire Suppression Program before the January 17, 2003 deadline. We have shown that a Single Engine Air Tanker Program would be the most cost effective way to suppress fires in Saskatchewan and would therefore be in the best interests of Saskatchewan's taxpayers.

We once again had the SAAA display in the Crop Production Show. I would like to thank Roland Jenson and everyone else that took time from their busy schedules to promote our industry. Our presence there has made the public and farmers more aware that aerial application is an integral part of agriculture.

The CAAA annual conference is fast approaching and I am looking forward to seeing everyone in Winnipeg!

# **Executive Director's Update**

As I sit down to write an update on recent events and issues, the office is in overdrive with numerous issues and projects in the works. An excellent board of directors meeting in Reno, December 2002 launched several new initiatives.

The following are some of the key issues the CAAA office is working on for you;

- The CAAA has written to several other associations with members who will be impacted by the new Transportation of Dangerous Goods requirement for fuel to gather information and assess their approach to the situation.
- We received the Transportation of Dangerous Goods Chapters from Transport Canada and will return them to members who submitted them. An online program is on the website to allow members to determine if the individual products they are applying are considered Dangerous Goods. For companies who are applying products requiring them to meet the Transportation of Dangerous Goods standards, the CAAA has a generic copy of the Operations Manual Chapter and is in the final stages of approval from Transport Canada on their training manual. Once completed these will both be available on the website.
- The CAAA is researching government grants for industry training and investigating the possibility of a seat on the PMRA Advisory Council.
- A Self Audit Program draft will be presented to the CAAA board for review in Winnipeg. Once complete it will be placed on the website for members use.
- The 2003 Partnership Package is underway. This is the annual opportunity for the CAAA and its partnership to reestablish their working relationship and set joint goals and objectives to work together to improve the aerial application industry. The Partnership Packages were mailed to potential partners in October and should be finalized by mid-February.
- The 2003 business survey has been completely re-designed based on member feedback and input. Major changes in-

clude; simplified questions, shorter format, improved collection procedures and should assure increased participation from members this year. The business survey is one of the association's most valuable marketing tools. The information provides a true picture of the enormous impact the aerial application industry has on agriculture in Canada. It is particularly valuable when approaching partners for funding and the government for regulatory changes. If you choose not participate in anything else this year, do not pass on the opportunity to complete the survey and provide the tools your association needs to assist your industry. Please complete the business survey you received and return it to the CAAA office by February 28, 2003.

A number of other projects are underway including the 2003 CAP Clinic planning, the development of online training oppor-

tunities for the website, production of the 2003 CAAA wall calendar and the annual membership campaign.

The CAAA office staff and I would like to recognize Jon Bagley, for taking time from his busy schedule to travel to Edmonton to update and improve our database. The improved database allows the CAAA to provide a higher quality service to our members and enhances the professional image of the CAAA. # Temporary Exhibition Focuses on Measures to Protect Quebec's Forests

The Société de Protection des Forêts ontre les Insectes et Maladies (SOPFIM), in conjunction with the Société de Protection des Forêts contre le Feu (SOPFEU) has agreed to take part in a temporary exhibition on forest protection at the Montreal Botanical Garden Tree House, during the summer of 2003.

Entitled "Guardians of the Forest", the exhibition's main objective is to promote awareness of the players involved in protecting forests from fires, insects, and diseases. In particular, the exhibit content will deal with the natural phenomena of insect epidemics and diseases, and will increase public awareness of the importance of protecting forests. The exhibition will also demonstrate the care and detail with which spraying programs are carried out as well as the role played by the environment in the protection process.

With its 1,500-ft<sup>2</sup> floor area, the exhibition hall will offer a particularly conducive setting for presenting various tools necessary for protecting Quebec's forests, such as night vision goggles, GPS navigation units, and quite possibly even a spray plane hung from the exhibition hall ceiling.

In short, a dynamic, interactive, and highly instructive exhibition is in store for the general public, enabling visitors to better understand how and why we intervene to protect Quebec's forest heritage. Opening day is planned for May 1, 2003 and the exhibition will run for a period of two years.

# Managing Brush Encroachment by Air

# New herbicides mean new tools for ranchers and new customers for aerial applicators

The aspen Parkland is in a 'tension zone' between two huge ecosystems—forest and grassland. It's part of the Parkland belt that stretches from Manitoba into British Columbia. It gets enough rain and snow during the year to support a modest level of aspen forest, but historically it was covered by grasses thanks to grazing buffalo and wild prairie fires, both of which no longer exist in their native forms.

For the past two or three generations, pastures have been let go in hopes of returning them to their original condition with aspen forest and adjacent scrub brush. For example, originally the University of Alberta research ranch at Kinsella, Alberta was probably about 95 percent grass covered. Now it is approximately 70 percent covered by trees and brush. The remaining 30 percent is just too dry to ever support tree growth again.

Now trees aren't bad, but studies show that grass supports about five times as much forage for cattle as aspen. With increasing land prices ranchers need to get maximum grass production from the land they have. There really isn't a magic bullet to get rid of brush forever in this tension zone, but ranchers can use several tools to manage it – aerial application of a new herbicide (Remedy\*) specifically for use in range and pasture is one of the tools. It's also an opportunity for aerial applicators to expand their services.

# **Curbing brush**

To get ahead of, or at least stop brush encroachment, ranchers need to pick and choose from four tools: mechanical clearing, controlled fires, controlled grazing and herbicide applications. Mechanical clearing of aspen and willow serves only to create more suckering, and can be very expensive in terms of equipment and time. Burning requires at least one full season of forage growth that must be sacrificed in order for the fire to burn hot enough. In most areas, burning is now frowned upon because of the high liability of damage to private property.

Unlike burning or bulldozing brush, new range and pasture herbicides have the added benefit of keeping the pasture in production as they are safe to the grass and have few grazing restrictions. Ranchers can continue grazing the pasture while controlling the brush or weeds. Another advantage is control right down to the root resulting in more sustainable results than mechanical control, and the elimination of re-suckering problems that mechanical treatments face.

Herbicides are a good strategy for areas that can't be controlled with grazing. They allow grasses to quickly compete and reclaim areas vacated by weeds and brush. Small, tender brush and aspen re-growth are easier to remove than mature material. Herbicide applications are most effective on brush less than ten feet high. An additional benefit in controlling brush ten feet or less is there is no headache of dealing with the deadfall.

The primary difference between spraying crops versus spraying pastures is how rough and inaccessible the terrain is. Pastures have rocks, stumps, snags and other obstacles that make it very slow, difficult, and expensive to apply by ground. Ground equipment can't get over the top of large brush effectively.

This provides a new opportunity for aerial applicators, which truly bring added value to a herbicide application by applying by air. This new value point was reflected in the price per acre aerial applicators were receiving in 2002 for pasture applications, ranging from \$10 - \$14/acre in the Prairie Provinces. The speed and convenience of aerial application is an additional benefit to managing brush with herbicides. Aerial applicators can bring a valuable service to ranchers wanting to increase their grass production.

# January 1, 2003—Changes come into effect regarding the Transportation of Dangerous Goods such as Jet A/Diesel or Avgas/Gasoline.

Fuel trucks and tanks that transport fuel on public roadways must meet Transport Canada Certification Requirements.

# **Tank Requirements**

- New Tanks are built to DOT 406 or TC 406 standards. These standards meet requirements for Jet A and Avgas. The 406 Standard includes engineered installation on a truck or trailer.
- TC 306 Tanks that were certified as of August 15,02 may continue to be used for Avgas and Jet A.
- Used Tanks that are built to TC 306 standards mounted on a truck or trailer can be certified provided they have the following three essential markings:
  - Date of Manufacture
  - -Date of Initial Test
  - Date of Certification
- Some TC 306 tanks do not have date of certification, which limits the future use of these tanks.
- A Non-Specification Tank that complies with inspection standards can be used for Avgas until 2005 and Jet A until 2010.
- There are very few small tanks that will meet tank standards. Some non-spec military tanks can be certified until 2005 for Avgas and 2010 for Jet A. Some older fuel truck tanks can also be certified, if they pass the tests, until 2005 for Avgas and 2010 for Jet A.
- In late December Transport Canada announced a permit for the delay of certification for tanks 5000 liters or less to Jan 1/05 for fuels with a flashpoint exceeding 37.8°C. i.e. Jet A or Diesel.

# **Tank Inspection Requirement**

- All tanks require:
  - External visual inspection every year
  - Leak test every year
  - Internal visual inspection, if equipped with a manhole, every 5 years
  - Pressure test every 5 years.
- All tests and/or inspections must be completed by a TDG approved repair and manufacture shop. i.e. Jasper Tanks or Advance Engineering.

# **Tank Availability**

- There are small tanks available from companies such as Hutchinson Tanks, Advance Engineering and Jasper Tanks that meet the new standards.
- The costs vary from:
  \$ 7,000.00 for a 500 gal tank
  \$ 8,500.00 for an 850 gal tank
  \$ 10,000.00 for a 1000 gal tank.
- To be certified these tanks must be mounted by the tank manufacturer. The manufacturer

must also install the pumping system.

• It seems the fuel delivery or pumping system is a gray area. Most tank manufacturers suggested that the pumping system, if it was not certified, be disconnected when travelling on a public roadway and hooked up again when on site.

DISTRIBUTOR FOR

 Another gray area is the issue of used tank mounting on trucks or trailers that do not meet engineered standards.

# Liability

- Transporting fuel on public roadways in trucks or tanks that are not certified is not only illegal but also means the owner and operator will not have insurance in the event of an accident or incident.
- Tanks that are mounted on trailers without engineered installation and Transport Canada approved rear bumpers leave the owner open to liability in the event of a serious accident.




